- Seen sub decree No. 35 ANK BK dated 26 April 1999 on the arrangement and the execution of Ministry of Industry, Mines and Energy
- Seen Inter-ministry Prakas No. 172 MIME and No. 291 MEF BK dated 27 March 2009 on the pricing the application form registration (license charge), extension, assignment of the mining license, annual land rental fee of the concession area for mining and/or mining exploitation and mineral resource charges.
- Seen letter No. 1715 MWRM dated 28 August 2009 of Ministry of Water Resources and Meteorology and as Chairman of Sand Resource Management Committee
- Seen proposal of company No. 697 MRG/09 of MONG RETHTHY GROUP Co., Ltd., dated 28 August 2009
- Seen the agreement on construction and muddy sand exploitation at Prek Thmor Rieng area, Sre Ambil district, Koh Kong province (border of Preah Sihanouk Province) between Ministry of Industry, Mines and Energy and MONG RETHTHY GROUP Co., Ltd., dated 01 September 2009.

Article 1: Authorized MONG RETHTHY GROUP Co., Ltd., with its address is based at house No. 152S, Preah Norodom Blvd, Phnom Penh, to conduct construction and muddy sand exploitation at Prek Thmor Rieng area, Sre Ambil district, Koh Kong province (border of Preah Sihanouk Province) of 22.56 hectares (twenty two point fifty six hectares only) for **export** abroad with the following coordinates:

- Article 2:** MONG RETHTHY GROUP Co., Ltd., shall conduct construction and muddy sand exploitation at Prek Thmor Rieng area, Sre Ambil district, Koh Kong province in accordance with the land area as designated above, and:
- Pay the raw material charge of construction and muddy sand at Treasury of Koh Kong Province/Preah Sihanouk Province through Ministry of Industry, Mines and Energy within 07 days before shipment of construction and muddy sand from the site and pay the annual land rental fees at National Bank of Cambodia
  - Ensure to abide by the mineral exploitation technical condition and ensure to protect the environment under the law
  - Pay the other taxes levied under the laws applicable
- Article 3:** If encountering the other deposits shall report urgently to the ministry. If any breach, this license will be confiscated and fined allowed by law on the mineral resources exploitation and management.
- Article 4:** This license is valid for 01 year from the date of signature. For at least 60 days before expiration of this license, MONG RETHTHY GROUP Co., Ltd., shall reapply for a new license.
- Article 5:** General Director of General Department of Mineral Resources, General Inspector of General Inspectorate, Director Department of Financial-Accounting, Director Department of Administration, Director Department of Industry, Mines and Energy Koh Kong Province/Preah Sihanouk Province and MONG RETHTHY GROUP Co., Ltd., shall carry out this license individually.
- Article 6:** This license comes into practice from the date of signature hereafter.
